

Welcome to our first issue of Herdsure® News for veterinary practices registered with the service.

Since its launch at the 2009 BCVA Congress, the Herdsure® Cattle Health Improvement Service has grown steadily and is now testing beef and dairy herds across the country.

Many veterinary practices have expressed an interest in the service and already 165 registered practices are offering Herdsure® to their clients.

More than 10,000 beef and 9,000 dairy cows are now being tested using Herdsure® protocols. We expect this number to increase significantly over the coming months as a number of regional projects are included in the service and it gathers momentum.

Second phase of protocols launched

The launch of the second phase means that six of the major diseases affecting profitability in cattle herds are now addressed by the Herdsure® Cattle Health Improvement Service.

The service now includes sampling, testing and management protocols for infectious bovine rhinotracheitis (IBR) leptospirosis, and neosporosis in addition to bovine viral diarrhoea (BVD), Johne's disease and liver fluke.

We are sending updated handbooks to vets and farmers who have enrolled herds. Please let us know if you have not received yours.

Tackling cattle abortion


The second phase of disease protocols includes a protocol for the control of neosporosis in dairy and beef herds. This is the first commercially available strategy for this major cause of abortion in cattle in the UK.

The protocol uses the ELISA test for detecting antibodies in blood samples. Once an animal is confirmed as positive it is important that its progeny are not used for breeding.

Due to the way the disease causes the animal's immune system to respond, samples must be collected from the cattle when they are less than two weeks old, or later in life during a specific period of pregnancy. Two negative tests are needed to be confident that an animal is free of infection.

Clearly all this makes the management of the herd, embarking on neosporosis control, an administrative challenge. We have therefore adapted the inhouse Herdsure® Management System to keep a record of all test results. By doing this we can update the testing history of all the cattle in the herd on a regular basis with those still needing to be sampled as well as the positive ones.

There's been a lot of early interest in this protocol with seven farms currently signed up to start testing.

When/where did you first hear about Herdsure®?

VLA colleagues had been telling me about this initiative when we discussed working together with some clients. It seemed just what we were after so we soon registered our interested clients when it was launched

Why did you opt for Herdsure®?

How many beef/ dairy are testing and what diseases are they testing for?

The launch of Herdsure® coincided with the West Midlands Herd Health Planning Initiative which was very fortunate for both sides as it provided a vehicle for us to introduce Herdsure® to our clients. We have some clients using the service who do not receive any grant-aided herd health planning

What feedback have you had from clients?

Our clients are positive about the whole herd health planning concept and accept our advice about Herdsure® being a useful platform to use.

- ✓ Please **do not sample until you receive the submission forms** with the instructions on which animals to test - otherwise you may have to repeat the tests.
- ✓ **If in doubt about the testing, please call us** - it's better to be safe than sorry!
- ✓ **Please use the correct test tube.** For example, green top heparin for BVD and red top for Johne's disease.
- ✓ **Ensure that each blood sample is traceable to an individual animal** otherwise results will be delayed for your clients.
- ✓ Remember that **VLA supply containers for individual bulk milk and faeces** while you need to supply containers for individual milk samples and blood samples. In every case you can use the postage-paid labels.
