1. General Information

This Import Information Note (IIN) must be read in conjunction with the IIN for general information for imports of live animals and germplasm, which provides information on pre-notifications, veterinary checks, risk categories etc.

References to European Union (EU) legislation within this document are references to direct EU Legislation which has been assimilated in Great Britain (assimilated direct

legislation), as defined in the Retained EU Law (Revocation and Reform) Act 2023 and can be viewed on the UK legislation website (legislation.gov.uk).

2. Scope

The import conditions for commercial imports of reptiles, amphibians and invertebrates, which include insects (with the exception of honeybees and bumblebees) and aquatic invertebrates (such as coral and star fish) and their genetic material.

This IIN does not include salamanders, honeybees and bumblebees, or aquatic animals such as crustaceans, molluscs and fish.

IMPORT REQUIREMENTS

All commercial transport of all vertebrate animals including reptiles and amphibians will be subject to the provisions of <u>Regulation (EC) 1/2005</u>. All animals including invertebrates must be transported in an appropriate way for the species involved.

Invertebrates, Reptiles, Amphibians for research, educational activities or research related to product development activities (not applicable for bees, molluscs and crustaceans) will require prior authorisation to enter GB. This will include to enter on licence, apply through CITC and then enter at any port of entry).

Entry into GB requirements relevant to these commodities:

- Comply with CITES (please see GOV.UK website CITES pages)
- Comply with the <u>Regulation (EU) 1143/2014</u> on the prevention and management of the introduction and spread of invasive alien species. Species listed as species of special concern under this regulation cannot be imported for commercial purposes.
- Comply with Plant Health Pests
- There are no animal health import requirements for these non-harmonised animals.

3. Country of origin

Imports are permitted from any trading partner.

4. Health certification/documentation

Animals within the scope of this IIN do not have animal health requirements, and therefore such imports into Great Britain do not need to be accompanied by veterinary health certification. However, consignments must be accompanied by:

- a commercial invoice and packing list containing detailed list of species, number of animals, premises of origin and premises of destination, contact details of the importer, and intended use of the animal (pet food, ornamental, pet sales, etc).
- an exporter declaration that the animals are 'fit to travel'.

5. Great Britain and Crown Dependencies

Trade movements between Great Britain, the Channel Islands and the Isle of Man are treated as national movements and as such, no animal health conditions are applicable to this type of animals.

6. Northern Ireland
