HARMONISED CHARGES FOR 2017

Purpose

1. To inform BIPs of the rate for harmonised charges in 2017 for veterinary checks on products of animal origin.

Background

2. Council Regulation 882/2004 lays down the minimum harmonised charge in Euros for imports of certain animals products. However it does not set a conversion rate so we are continuing to use the rate published in the first C series Official Journal published in September of the preceding year. The rate for 2017 is £0.84806. Conversion tables for the minimum charge are attached. This rate should also be used for reduced charges in the equivalence agreements.

Action for OVSS

3. To update the minimum fees in line with the annex and to notify stakeholders.

€6.98 per tonne, up to 46 tonnes	£5.92
€326 per consignment over 46 tonnes	£276.47
