HARMONISED CHARGES FOR 2018

Purpose

1. To inform BIPs of the rate for harmonised charges in 2018 for veterinary checks on products of animal origin.

Background

2. Council Regulation 882/2004 lays down the minimum harmonised charge in Euros for imports of certain animals products. However it does not set a conversion rate so we are continuing to use the rate published in the first C series Official Journal published in September of the preceding year. The rate for 2018 is £0.91973.
3. The Conversion tables for the minimum charge are listed below in the Annex to this note. This rate should also be used for reduced charges in the equivalence agreements.

4. To update the minimum fees in line with the annex and to notify stakeholders.

A. Minimum harmonised charge in Regulation (EC) No 882/2004

Fresh meat, meat products, poultry meat, wild game meat, rabbit meat, farmed game meat, by-products and feed of animal origin

B. Equivalence Agreements

All products from New Zealand (as above with 22.5% reduction in accordance with Annex VIII of Decision (EU) 2015/1084)¹	
€42.63 per consignment up to 6 tonnes	£39.21
€6.98 per tonne, up to 46 tonnes	£6.41
€326 per consignment over 46 tonnes	£299.84

¹ However, for the transit of goods through the Union, inspection fees shall be applied without the reduction
