UPDATE - OUTBREAKS OF HIGHLY PATHOGENIC AVIAN INFLUENZA IN THE USA AND CANADA

Purpose

1. To inform you of the latest situation following outbreaks of highly pathogenic avian influenza (HPAI) H5N1 in the USA and Canada.

Background

2. In accordance with [Retained EU Regulation 798/2008](#), the whole territories of Canada and USA are approved to export the following commodities to GB:
 - SPF eggs (SPF)
 - Eggs and egg products (E, EP)
 - Wild game meat of birds (WGM)
 - Breeding poultry breeding ratites (BPP, BPR)
 - Less than 20 units of poultry (LT20)
 - Day old chicks of poultry and ratites (DOC, DOR)
 - Hatching eggs for poultry and ratites (HER, HEP)
 - Poultry and ratites for slaughter (SRP, SRA)
 - Poultry meat and ratites meat (POU, RAT)
3. In line with Agreements in place between GB and both countries, imports of poultry commodities will continue to be permitted from outside the affected zones.
4. Safeguard measures have been adopted for a number of outbreaks (see [Annex I](#)).
5. There are also additional outbreaks in other parts of the USA and Canada and further risk assessments are being carried out. In the meantime, if you receive consignments of poultry or poultry products including animal by-products derived

from poultry from affected regions of the USA and Canada shown in the table in [Annex II](#) below, please hold the consignment and contact APHA for further advice.

6. The table should be read in conjunction with the existing information in the declarations.
