### RETAINED EU LEGISLATION ON LEGISLATION.GOV.UK

#### Purpose

1. To provide clarification about legislation that is available via [Legislation.Gov.UK](https://www.legislation.gov.uk)

#### Background

2. Schedule 5 to the European Union (Withdrawal) Act 2018 as amended by the European Union (Withdrawal Agreement) Act 2020 Sch.5 para. 48, requires that we make arrangements for the publication of EU Regulations, EU Decisions, and EU tertiary legislation published on EUR-Lex up to 11.00 p.m. on 31 December 2020.

*The Act also gives the power to publish other legislation documents that may be useful, and [legislation.gov.uk](https://www.legislation.gov.uk) therefore also includes corrigenda (correction slips for EU legislation) and EU Directives as published on [EUR-Lex](https://eur-lex.europa.eu) published up to 11.00 p.m. on 31 December 2020.*

3. Elements of European legislation, as it stood on 31<sup>st</sup> December 2020, are published on Gov.uk and have been retained in GB law under the above Act and has become GB law. In order to ascertain whether a piece of EU legislation has been retained in GB law, you should search for the legislation in the normal way and then click on

4. All the retained EU law that has already been updated in legislation.gov.uk will return a result showing that it has been amended by an EU Exit SI. If it is not GB Retained law the return will not include any amendments by and EU Exit SI (see the examples in the Annex).
