# CHANGES TO MANAGEMENT OF APPROVED COUNTRY LISTS FOR IMPORTS OF ANIMAL BY-PRODUCTS AND CERTAIN PRODUCTS OF ANIMAL ORIGIN

#### **Purpose**

- 1. To inform you of changes to the management of the approved country lists for imports of the following commodities:
  - a. Live, chilled, frozen or processed bivalve molluscs, echinoderms, tunicates and marine gastropods for human consumption
  - b. Other fishery products
  - c. Frogs' legs and snails intended for human consumption
  - d. Insects intended for human consumption
  - e. Animal by-products.

#### **Background**

- 2. The UK's approved country import lists for animals and animal products to Great Britain allow for country-specific import conditions to be published outside of legislation, facilitating the prompt amendment of import conditions. These administrative lists are published online <a href="here">here</a> for EU/EFTA countries and <a href="here">here</a> for non-EU countries. The lists already managed in this way are set out in Annex I.
- 3. From 10 February 2025, approved country lists for imports of the following animals and animal products will also be published on <a href="www.gov.uk">www.gov.uk</a> rather than in UK legislation:
  - a. Live, chilled, frozen or processed bivalve molluscs, echinoderms, tunicates and marine gastropods for human consumption
  - b. Other fishery products
  - c. Frogs' legs and snails intended for human consumption
  - d. Insects intended for human consumption
  - e. Animal by-products.

This is due to recent legislative changes delivered through <u>The Official Controls</u> (Amendment) Regulations 2024.

- 4. This means that, from 10 February 2025, the latest country listings information for imports of the above commodities can be found at the following links (please note that this information will only be available to use from this date):
  - <u>EU and EFTA countries approved to export animals and animal products to</u> Great Britain
  - Non-EU countries approved to export animals and animal products to Great Britain
