

APHA Briefing Note 14/17

Changes to payment of Official Veterinarian Services – England and Wales

Purpose

- 1. To inform Official Veterinarians (OVs) of changes to the payment of OV services in England and Wales.
- As of 7 July 2017 all miscellaneous claims for OVs previously paid via the submission of AH49 forms and OVc5/OVc6 forms will need to be claimed via an invoice issued by the OV practice. The self-billing system APHA previously had in place has been decommissioned.

Background

- 3. Please submit all invoices on a monthly basis to include all services completed. To ensure that payments are made promptly, please include all of the following information:
 - Unique Invoice number
 - Practice details; registered trading name, address (ideally letterheaded to include vat registration number)
 - Date of visit
 - CPH number and farm/customer name
 - Detail of task, and appropriate fee (headage or hourly as appropriate), including number of animals and/or hours – as per the Scale of Fees below
 - Detail of mileage being charged

- VAT (at the appropriate rate) should be shown separately on the invoice as a separate charge. VAT is not included within the scale of fees.
- 4. Invoices should be sent by email to: FinanceEnglandServiceDelivery@apha.gsi.gov.uk.
- 5. Please include the following in the subject title: 'OV Miscellaneous Claim' followed by the Practice name. The Finance Team can be contacted on 02080 265644 if emailing invoices is not an option.
