## Notice Prohibiting Movement of Specified Animals

To:

### Restriction on Movement of Animals specified below onto or Off Premises Where Tuberculosis is Suspected

In Accordance with Article 18 of the Tuberculosis (England) Order 2014, Article 16 of the Tuberculosis (Scotland) Order 2007 (as amended), Article 20 of the Tuberculosis (Wales) Order 2010 (as amended), Article 12 of the Tuberculosis (Wales) Order 2011 (as amended), Articles 9 and 14 of the Tuberculosis (Deer and Camelid) (England) Order 2014 and Article 12 of the Tuberculosis in Specified Animals (Scotland) Order 2015

I, being a Veterinary Inspector of the Secretary of State/Scottish Ministers/Welsh Ministers\* reasonably believe that animals kept on your premises is/are or may be infected with TB and I hereby give you notice as the occupier of the following premises:

that you must not move any animals specified below onto or off the premises

Unless:

- You are issued with a licence authorising you to move them, or
- An Inspector serves a notice to revoke this Notice.

The prohibition on movement contained in this notice does not apply to animals which are moved in an emergency to a place of slaughter or veterinary treatment so as to prevent the unnecessary suffering of that animal. In such cases full details must be given to an Inspector at the earliest opportunity.

I also give you notice that the following additional restrictions or requirements must be complied with in order to prevent the spread of disease:

## Isolation of Animals Affected or Suspected of being Affected with Tuberculosis

In accordance with Article 18 of the Tuberculosis (England) Order 2014, Article 16 of the Tuberculosis (Scotland) Order of 2007 (as amended), Article 20 of the Tuberculosis (Wales) Order 2010 (as amended), and Article 14 of the Tuberculosis (Wales) Order 2011 (as amended) for Wales, Articles 9 and 14 of the Tuberculosis (Deer and Camelid) (England) Order 2014 and Article 12 of the Tuberculosis in Specified Animals (Scotland) Order 2015

I being a Veterinary inspector of the Secretary of State/Scottish Ministers/Welsh Ministers\* reasonably believe that animal(s) kept on your premises is/are or may be infected with TB and I hereby give you notice as the occupier of the following premises:

that the following animals:

shall be isolated from other livestock and kept under control in the following area of the above-mentioned premises:

This notice shall remain in force until such time as the animals listed above die, are moved directly to a slaughterhouse under licence or it is withdrawn by a further notice in writing issued by a Veterinary Inspector. Failure to comply with the provisions of this notice is an offence under the Animal Health Act 1981.

### Note

Animal means any kind of mammal except a bovine animal or man.

### Additional Conditions for Keepers of Goats, Camelids and Deer Included in this Notice, Which are Located in Wales

The Keeper of goats, camelids and deer included in this Notice, which are located in Wales, is required to:

(a) treat and store manure or slurry from any place which has been used by any such non-bovine animal in accordance with the requirements of the notice

(b) not to spread any manure or to spray or spread any slurry from any place which has been used by any such non-bovine animal otherwise than in accordance with the requirements of the notice

(c) not to remove manure, slurry or other animal waste from the premises except under the authority of a license issued by an Inspector

(d) take such steps as may be reasonably practicable to prevent any non-bovine animal kept on the premises from infecting any animal kept on any adjoining premises

(e) arrange for the isolation of any non-bovine animals which may be specified in the notice to the extent specified in the notice

(f) ensure that any part or parts of the premises specified in the notice are not used by any non-bovine animal on the premises, or by such other animal or animals as may be specified in the notice

(g) to cleanse and disinfect with an approved disinfectant such part or parts of the premises, within such time and in such manner, as may be specified in the notice

(h) cleanse and disinfect with an approved disinfectant all utensils and other articles used for or about a non-bovine animal to which the notice relates, within such time and in such manner, as may be specified in the notice, and

(i) take such other action as the Veterinary Inspector considers appropriate.

## Dairy and Food Hygiene Regulations

### Public/Human Health Protection

#### Milk Sales

When a herd/flock/individual is placed under TB movement restrictions, a number of additional rules under EC Regulation 853/2004, laying down specific hygiene rules for food of animal origin, apply:

1. The owner or person in charge must contact their milk buyer to ensure that all milk is to be heat treated before being sold for human consumption.
2. Milk from individual animals showing a positive reaction to the tuberculin test must not be used for human consumption. Milk from these animals must be withheld and it is not recommended that this is fed to other livestock. The milk can be collected in a slurry system, but subsequent landspreading must be in accordance with a registered Waste management Licence Exemption. To register, contact either the Environment Agency in England and Wales (or use the Defra Whole farm Approach in England only) or the Scottish Environment Protection Agency (SEPA) in Scotland.

Additionally, to safeguard your own health and that of your family, it is strongly recommended that you do not consume unpasteurised milk while there is disease in your herd/flock.
